8. The first party may be introduced as a resource to any governing machinery that seeks information for the college's placement avenue. The first party may need to interface, interact and provide information to these bodies, if required.
9. Establishment cost, if any may be mutually agreed upon for hassle free functioning of schemes apart from other financial implications and involvement, if any.

The collaborative activities as per this Memorandum of Understanding shall be governed by the rules and regulations of both the concerned institutions. This agreement will take effect from the date of its signing and shall be valid for a period of 3 years from that date and may be extended by mutual written agreement.
